### 3. AIMS AND OBJECTIVES :

- i. To promote social and educational activities among the masses.
- ii. To eradicate illiteracy.
- iii. To impart education, academic, vocational, technical etc. without any discrimination of caste creed or religion.
- iv. To inculcate interest in education among discontinued candidates.
- v. To propagate foreign languages like English, French, German etc among Indian Students, enabling them to communicate effectively with foreigners and develop International outlook.
- vi. To undertake foreign tours with a view to study the latest trends in the educational Systems in various fields.

## RULES AND REGULATIONS OF THE SOCIETY :

1. Name of the Society : "VIDYA EDUCATIONAL SOCIETY".
2. Location of the office : "H.NO.8-3-231/B/95,96, Sri Krishna Nagar,  
Yousufguda, Hyderabad - 500045.
3. (a) Members : Any Indian Citizen who is major and of sound  
mind is eligible for membership, provided he/she  
subscribes to the aims and objectives of the Society,  
subject to the payment of the prescribed admission  
fee and annual subscription.

- (b) Category of Members : Life Members.  
(c) Admission fee : Rs. 2,000/-.  
Annual Subscription : Annual subscription Rs. 50/-.

### 4. General Body

A. Constitution : The General Body of the Society shall consist of members as stipulated  
in 3(a) supra. It shall be the supreme policy making you.

B. There shall be a meeting of the General Body of the Society once in a year and it shall  
be held before the end of the second quarter of the accounting year.

C. The General Body shall meet :

1. To confirm the minutes of the proceedings of the Annual General Body meeting.
2. To consider the Annual statements of the accounts and the balance sheet for the  
Previous year.

- To consider the audit note if it has been received.
4. To confirm or otherwise consider the admission or expulsion of member or members.
  5. To prepare a plan for the working of the Institution.
  6. To elect a Treasurer for safe custody of money of the Society to and a Secretary to maintain accounts, Registers and to supervise the activities of the Institution.
  7. To appoint the auditor for the ensuring year and to fix his remuneration.
  8. To pass the budget for the ensuring year.
  9. To collect, accept, maintain, manage and control funds for the attainment of the objectives of the Society and/or its dependant aided institutions.
  10. To do other such acts and things which are conducive or incidental to attainment Of the above objectives.

D. It shall have the power to interpret and amend the general rules and regulations of the Society.

E. The Secretary shall notify the date of holding the General Body Meeting in the notice Board of the Society at least 15 days in advance of the date of the meeting.

F. The Governing Body at its discretion may submit for the consideration of the Annual General Meeting any proposal not included in the Agenda.

G. Quorum : The quorum for the General Body Meeting shall be  $\frac{1}{2}$  ( Half ) of the members including the members of the Governing Body and that of the Governing Body shall of  $\frac{1}{4}^{\text{th}}$ .

5. i ). The exact number of the Governing Body including the Office Bearers shall be five ( 5 ) i.e. President, Vice-President, Gen.Secretary , Joint.Secretary and Treasurer.

i) (a) "The members of the Executive Committee (Governing Body) shall be duty-bound to attest the signatures of all the members of newly elected Executive Committee (Governing Body) and to see that said signatures in shape of an annual list as filed with the Registrar of Society before 15<sup>th</sup> day of the succeeding month of the month in which elections were held".

ii) Functions of the Governing Body : Subject to any regulation and restrictions laid down by the General Body or in the bye-laws, the Governing Body shall exercise all the powers of the Society more particularly :

1. To maintain accounts of all money received or disbursed.
2. To keep accounts of the assets and liabilities of the Society.
3. To keep a register of members up-to-date.
4. To prepare and lay before the Annual General Body Meeting the income and Expenditure account and the Balance Sheet.
5. To examine the accounts, sanction contingent expenditure and supervise the maintenance of the prescribed registers.
6. To fix up remuneration's for various type of employees.
7. To frame special rules for execution of day-to-day affairs subject to approval Of the General Body.
8. To consider the Inspection Notes of the Register and his subordinates and take Necessary action.
9. To elect or remove or expel members subject to confirmation by the General - Body meeting.
10. To summon General Meetings in accordance with the bye-laws.
11. To assist in the inspection of the books by any person authorised to see them.
12. To appoint, dismiss, remove, suspend or otherwise, punish any salaried and Non-salaried officers of the Society and required all or any of them to furnish Security.

(ii). Functions of Office Bearers :

President : He presides over the meeting of the both General Body and Governing Body. He can exercise his casting vote in case of tie. He can supervise all the branches of the Society.

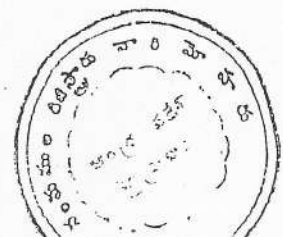
Vice-President : He will assist the President in discharging his functions. In the absence Of the President he will perform the duties of the President as instructed by him.

Secretary : ( 1 ) The Secretary shall be the Chief Executive of the Society. ( 2 ) He or she shall be the custodian of all records pertaining to the Society. ( 3 ) He or she shall Record or cause to record all the minutes of the Society. ( 4 ) He or she shall cover both the bodies of the Society i.e. General Body and Governing Body with the permission of President. ( 5 ) He or she shall guide the Treasurer in preparing the budget and expenditure statements to place before General Body for its approval. ( 6 ) He or she shall be empowered to enter into agreement or agreements with outsiders for and on behalf of the Society with the approval of the Governing Body. ( 7 ) He or she shall have the necessary power on the society or its dependent aided institutions and take such disciplinary action against the erring employees as he or she may deem fit by way of fines, suspension etc.. ( 8 ) He or she shall have power to raise loan or loans from Bank, Corporation, Corporate Bodies and Private individuals to meet the necessary expenses for the attainment of the objectives of the Society, at such rate or rates of interest as he or she deems fit and repay the same from the funds of the Society.

Joint Secretary : He has to perform the work entrusted by the Governing Body. He has to assist the Secretary in discharging his duties. In the absence of the Secretary he can perform the duties of the Secretary.

Treasurer : He or she is a responsible person for all the financial

Relating to the Society. He has to maintain accounts of the property along with the vouchers. He has Society with the guidance of the Secretary.

6. i) Funds : The funds shall be spent only for the attainment of objectives of the Society.


No portion there of shall be paid or transferred directly or indirectly to any of its members through any means.

ii) A Bank account shall be opened and operated by either President or Gen. Secretary of the General Body.

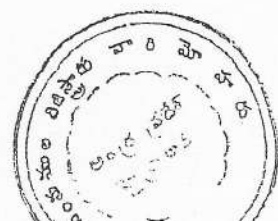

Winding up : In case of the Society has to be wound up, the properties and the funds of the Society that remain after full satisfaction of all liabilities of the Society shall be transferred to some other Institution with similar aims or objectives, registered under Section 12-A of the Income Tax Act, 1961.
